

SANITATION FISCAL REPORTS - Ratified

The Board considers a list of claims recommended for ratification by the District Engineer.

Upon motion of Director Leopold, duly seconded by Director Friend, it is ordered by the Board, by unanimous voice vote, that the list of paid invoices for ratification, for the month of December, Fiscal Year 2014-2015, in the amount of \$1,129,172.14 and for the month of January, Fiscal Year 2014-2015, in the amount of \$692,894.28, be and is hereby ratified.

2015/2016 SEWER SERVICE CHARGES NOTICE OF PUBLIC HEARING -approved

The District Engineer, John Presleigh, introduces the District's consultant, Gary Hornberger, who explains the subject item for the Board's information, stating that the overall fee increase for the next fiscal year is 4.3% which is lower than the 4.5% expected. Board discussion ensues, with Director Friend and Chairperson Harlan making some minor revisions to the mailer. It is recommended that the Board consider setting a public hearing for adoption of an ordinance amending District Code.

CLEAN WATER STATE REVOLVING FUND LOAN APPLICATION

-Res. #15-01 adopted

Members of the Board:

The plans, specifications, and engineer's estimate have been completed and are presented here for your Board's consideration and approval. The engineer's estimate for the project is \$2,839,800.00, not including contingencies, inspection and administration costs. Sufficient funds are available in the project budget. A Clean Beaches initiative grant from the State Water Resources Control Board will fund up to 25 percent of the project costs.

The work for the subject project will provide for the construction of an approximately 725 feet of new force main crossing Soquel Creek, pump station improvements including concrete repairs, and odor control system improvements. The project will take an estimated 160 working days to complete.

It is therefore recommended that your Board take the following actions:

1. Approve the plans, specifications, and engineer's estimate, and authorize calling for bids.
2. Set the bid opening for 2:15 p.m., on Thursday, May 7, 2015, in the Department of Public Works conference room.
3. Direct the District Secretary to advertise a "Notice to Contractors" in accordance with the provisions of Public Contract Code Section 20783.
4. Direct the District Engineer to return on or before June 11, 2015, with a recommendation for award of the contract.

5. All contractors and subcontractors must furnish electronic certified payroll records directly to the Labor Commissioner (aka Division of Labor Standards Enforcement).

In accordance with California Labor Code 1771 and 1725.5, all listed subcontractors must be registered with the Department of Industrial Relations. 

Attached please find the plans, specifications, and engineer's estimate for Neary Lagoon Force Main Rehabilitation project presented here for your Board's consideration and approval. The engineer's estimate for the project is \$770,000.00, not including contingencies, inspection and administration costs. Sufficient funds are available in the 2014/2015 Construction Improvement Fund budget. A Clean Beaches Initiative grant in the amount of \$350,000.00 has been awarded by the State Water Resources Control Board to partially fund this project.

The work for the subject project involves rehabilitation of approximately 1,500 lineal feet of 36-inch diameter bar-wrapped pipe (AWWA C303) wastewater force main using a Cured-in-Place-Pipe (CIPP) lining process along the Neary Lagoon portion of the force main, associated sewage flow bypass, sewer force main cleaning, debris disposal, installation of access tees, pre- and post-construction internal inspection, pressure and leakage testing, and any spot repairs as needed. The project will take an estimated 120 working days to complete.

It is therefore recommended that your Board take the following actions:



Members of the Board:

The Santa Cruz County Sanitation District is nearing completion of the construction of the Moran Pump Station Upgrade Project. The contractor for the subject project is Anderson Pacific Engineering Construction, Inc. (Anderson Pacific), of Santa Clara, California. The project involved removal of the existing pumps and installation of new pumps, concrete bases, valves and associated piping.

The contract did not include sufficient funds for electrical work. Anderson Pacific performed additional electrical work as the new pumps have integral motors which eliminate the need for drive shafts.

District staff recommends Anderson Pacific be compensated for the additional electrical upgrades. Attached is the Contract Change Order No. 1 in the amount of \$40,000 for the work item. Sufficient funds are available with a transfer of funds from general engineering.

It is therefore recommended that your Board take the following actions:

1. Approve the Contract Change Order No. 1 in the amount of \$40,000.
2. Approve the attached Request for Transfer of Funds and Approval of Agreement, and
3. Direct the District Secretary to process said Contract Change Order and take related actions.




