Fee Schedule for Loads Coming from Unincorporated Santa Cruz County and City of Scotts Valley

HAZARDOUS WASTE IS PROHIBITED IN TRASH OR LANDFILL

Customer Notice	Requirement
Surcharge	Loads from the Cities of Capitola, Santa Cruz, Watsonville, and outside Santa Cruz County are subject to a 28% surcharge.
Residency	Proof of residency is required for all loads.
Payment	Accepted forms of payment: cash, checks, and major credit cards. Credit card fees apply.
Load checking	All loads may be checked for hazardous waste. Hazardous and other prohibited materials cannot be disposed of at County facilities. If these materials are found, the hauler must pay all costs to handle them. The County may report the issue to state or local agencies. Responsible parties may face civil or criminal penalties.
Unload deadline	Customers must finish unloading within 15 minutes after closing. If you cannot unload by then, the Special Handle rate may apply.

**Items are accepted at the discounted rate listed only when market conditions support recycling of the material. The Director of Community Development and Infrastructure will determine applicability of the discounted rate with 30 days advance notice; otherwise refuse rates apply. GARBAGE DROP BOX / ROLL OFF RENTALS: Hauler must be a Franchised Hauler with the County of Santa Cruz. Buena Vista Landfill only. Drop box reloading fee: \$172.50 per occurrence.	\$93.25/TON	\$31.50
SPECIAL HANDLE REFUSE: Includes agricultural plastics, large non-recyclable metal items, rancid waste, dead animals, waste requiring supervised burial, and any waste requiring special handling as determined by facility staff. Not accepted at Ben Lomond Transfer Station.	\$172.50/TON	\$45.25
CONTAMINATED / NON-COMPLIANT GARBAGE, REFUSE AND TRASH: Garbage loads containing sortable recyclable materials that are disposed of in the garbage and contain more than 5% recyclable material in violation of County Recycling Ordinance, as determined by County staff.	\$202.50/TON	\$55.25
CLEAN SORTED WOOD WASTE & YARDWASTE: No refuse, dirt, treated or painted lumber, poison oak, pampas grass, bamboo, yucca, palm, root balls, or materials over 8 ft. length x 2 ft. diameter, 4 ft. length x 3 ft. diameter, or 2 ft. length x 4 ft. diameter.	\$70.00/TON	\$22.50
FOOD WASTE (SCRAPS): Fruits, vegetables, dairy products, grains, bread, coffee grounds and filters, eggshells, cooked meats and bones. No plastic, grease, glass, metal, raw meats, compostable or non-compostable utensils/service ware, condiment packages, or Styrofoam.	\$103.50/TON	\$31.00
SHEETROCK / GYPSUM BOARD**: No refuse, dirt, or other contaminants.	\$57.75/TON	\$23.50
CLEAN CONCRETE: Maximum size 3.5 ft. x 3.5 ft. x 8 in. No dirt, no concrete with exposed rebar or pipe, and no oversized concrete. Must be able to unload by hand. LIMIT ONE CUBIC YARD PER TRIP.	\$103.00/TON	\$30.75
CLEAN ASPHALT: No dirt. Must be able to unload by hand. LIMIT ONE CUBIC YARD PER TRIP.	\$103.00/TON	\$30.75
BASE ROCK, BRICK, TILE & PORCELAIN: No concrete contaminated fees will apply. Must be able to unload by hand. LIMIT ONE CUBIC YARD PER TRIP.	\$103.00/TON	\$30.75
CARPET / FOAM CARPET PADDING**: Must be clean, dry, and rolled in 6 ft. sections, free of debris. Roll carpet and padding separately. Must be loaded into container to receive reduced rate.	\$57.50/TON	\$22.25

ALL LOADS MUST BE PROPERLY TARPED AND/OR SECURED

Vehicles arriving at the landfill/transfer station with loads that are not properly secured will be subject to a surcharge of the uncovered/unsecured load fee. Uncovered trucks are one of the primary sources of litter found along our roadways.

California Vehicle Code: VEH § 24002, VEH § 23114, and VEH § 23115.

General Acceptance Requirements

Topic	Requirement	Customer Note
Vehicles and VIN-Bearing Items	Mobile homes, trailer homes, cars, trailers, boats, motorcycles, and other vessels or items with a Vehicle Identification Number (VIN) <u>are not accepted</u> for recycling or disposal.	Do not bring VIN-bearing vehicles or vessels to the landfill or transfer station.
Airspace / Water Weight	Discounts are not provided for airspace or water weight, including excess rainwater or wet loads.	Customers are responsible for load condition at the time of disposal.
Commercial Hazardous Waste and Asbestos	Commercial hazardous waste and asbestos are not accepted. Businesses needing hazardous waste guidance should contact County Environmental Health at (831) 454-2022.	County Environmental Health: scceh.com/NewHome/AboutUs/ContactUs.aspx
State Disposal Fee	All refuse disposal loads include the applicable California Integrated Waste Management Fee of \$1.40 per ton.	Fee is applied to refuse disposal loads.
Scale / Computer Outage	If the scale or computer system is inoperable cubic yard (CY) rates apply: Compacted Refuse: \$52.75/CY; Wood/Yard Waste: \$22.50/CY	Loose Refuse: \$31.50/CY; and Special Handle Waste: \$45.25/CY
Mixed Loads / Contaminated Loads	The higher unit rate applies to mixed loads and contaminated wood waste loads.	Customers should sort loads before arrival when possible.
Senior Citizen Discount	A senior citizen discount of \$2.00 per load is available for customers age 65 or older. The discount applies only to self-hauled residential refuse and yard waste.	Discount does not apply to commercial, industrial, or non-eligible materials.
Load Inspections	Commercial, industrial, and residential loads are subject to periodic inspection for hazardous or unacceptable wastes. Commercial or industrial loads containing hazardous waste will be turned away, and incident information may be referred to County Environmental Health for further action.	Loads must comply with posted acceptance policies and staff direction.
Dead Animals	Every effort should be made to deliver dead animals to the landfill between 9:00 AM and 2:30 PM. Dead animals must be double bagged.	Contact the facility if special handling is needed.
Special Handling - Wood Waste	The Special Handle rate applies to wood waste loads containing dirt, refuse, wood waste over 8 feet in length or over 4 feet in diameter, or other non-acceptable materials identified in the Wood Waste and Yard Waste Acceptance Policy.	Oversized or contaminated material may be charged at a higher rate.

Treated Wood Waste (TWW) Disposal Policy

TWW must be declared at the scale, documented, pre-sorted, and hand-unloaded into the designated bin. Mechanical dumping is prohibited unless authorized by County staff.

Requirement	Policy
Eligible source area	Santa Cruz County addresses only, including unincorporated areas and Capitola, Scotts Valley, Santa Cruz, and Watsonville.
Pre-sort / segregate	Separate TWW from all other material before arrival. Mixed or unsegregated loads may be rejected.
Scale declaration / tracking	Declare TWW at the Scale House. County staff will weigh the load and collect required customer/load information per DTSC requirements.
Hand unload / payment	Hand unload into the designated TWW bin, then return to the Scale House to complete payment.
Transport compliance	Customers are responsible for applicable DTSC ID, transporter, or variance requirements when required.

Note: Disposal charges apply at the garbage rate unless otherwise specified. Loads must follow staff direction and posted acceptance requirements.

Household Hazardous Waste (HHW) Disposal

HHW includes paint, solvents, pesticides, auto fluids, cleaners, aerosols, pool chemicals, and similar products. Use approved HHW collection services. Details: HHW.SantaCruzCountyCA.gov.

Eligibility: Residential HHW is free for unincorporated County, Scotts Valley, Capitola, and Santa Cruz only; proof of residency required. Watsonville residents call (831) 768-3133. Business/VSQG is appointment-only at Buena Vista Wed./Fri.; Santa Cruz County waste only; monthly limit under 100 kg / 220 lbs. hazardous waste and under 1 kg extremely hazardous waste. Over limit: (831) 454-2022.

Transport: Keep HHW labeled and upright; do not mix chemicals. Unsafe, leaking, unlabeled, unknown, excessive, commercial, or non-accepted waste may be refused. Emergencies: call 911.
