2024/25 SEWER SERVICE CHARGE REPORT - PUBLIC HEARING

Members of the Board:

Ordinance No. 154, adopted February 15, 2024, provides for collection of the District's sewer service charges on each year's tax roll, pursuant to Section 5471 through 5473.11 of the Health and Safety Code of the State of California. Accordingly, on May 16, 2024, the Board set today, June 13, 2024, as the time of the public hearing on the service charge report for sewer service charges on property within the Santa Cruz County Sanitation District.

The purpose of today's hearing is for the Board to hear and consider all objections or protests, if any, to the written report of service charges. The written report containing the assessor's parcel number, the property use code, assessed value and improvements, and the amount of the sewer service charges was filed for public review on, or before, May 30, 2024, with the District Secretary, and also posted on the District's website. Attached is a copy of the sewer service charges based on the approved charges.

It is recommended that the Board of Directors hold the public hearing and then consider the adoption of the attached resolution overruling protests and confirming the report on sewer service charges for the fiscal year 2024/25.

# A RESOLUTION OF THE SANTA CRUZ COUNTY SANITATION DISTRICT OVERRULING PROTESTS AND CONFIRMING REPORT ON SEWER SERVICE CHARGES FOR THE FISCAL YEAR 2024/25

RESOLVED, by the Board of Directors of the Santa Cruz County Sanitation District, Santa Cruz County, California, that

WHEREAS, on May 16, 2024, this Board appointed the time and place of public hearing on said report and directed notice, which notice was duly given in the manner provided by law as appears by the affidavits of publication on file in the office of the Secretary of said District; and

WHEREAS, a written service charge report was filed with the District Secretary on, or before, May 30, 2024, containing a description of each parcel of real property receiving services and facilities from the District and the amount of the service charges to be collected on the County Tax Roll for each parcel for the 2024/25 fiscal year; and

WHEREAS, said matter came on regularly for hearing at the time and place fixed and all written protests and other communications were publicly read at said meeting and all persons desiring to be heard were fully heard.

## NOW, THEREFORE, IT IS DETERMINED AND ORDERED, as follows:

- 1. That objections to, and protests against, said report were not made by the owners of a majority of the separate parcels of property described in the report;
- 2. That all objections to and protests against said report have been heard by this Board and that said objections and protests be, and each of them is, hereby overruled;
- 3. That said report is hereby adopted in full without revision and modification pursuant to Health and Safety Code Section 5473.3, and that the charges as specified in said report shall be collected on the tax roll of the County of Santa Cruz, in the manner provided by law;

- 5. The Auditor-Controller Treasurer Tax Collector of Santa Cruz County shall. upon receipt of said report, enter the amounts of the charges against the respective lots or parcels as they appear on the assessment roll for the fiscal year 2024/25.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Santa Cruz (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

# Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

# Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

# Consequences of changing your mind

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you.
