# Medical Office Building Project Environmental Impact Report Scoping Meeting Summary

April 2, 2020, 6 p.m. - 7:30 p.m.

The scoping meeting for the Medical Office Building Environmental Impact Report (EIR) was held online via GoTo Meeting and within the Planning Large Conference Room at the County Government Center. Approximately 45 online participants (including members of project team) attended.

Stephanie Hansen, Principal Planner, County of Santa Cruz, opened the meeting and began the presentation at 6:15pm:

- Explained online meeting format due to Covid-19 and established ground rules for comments and discussion
- All online meeting participants will be muted during presentation and unmuted as needed for comments to give everyone an opportunity to speak
- Presentation will be available online with associated material

## Ms. Hansen introduced project team:

### Mr. Dix presented the meeting outline and began introduction:

Purpose of scoping meeting: first step to initiate the EIR process

## Ms. Hansen presented the project overview:

- Project Site 5940 Soquel Avenue, Live Oak
- Project Setting South of Highway 1 between Chanticleer Avenue and Mattison Lane
- Project Site Aerial
- Project Description & Conceptual Site Plan four-story medical office building with a range of services, including a five-level parking garage, site and access improvements, and offsite improvements that include drainage to Rodeo Gulch
- Site Renderings
  - Main building on left, parking garage on right
  - Visual screen around parking garage facades
  - Landscaping and trees and variety of plantings to soften the main structure and parking garage

#### Mr. Dix presented the environmental review process

- Purpose and Requirements of CEQA
  - CEQA process needed for projects that require discretionary approval
- The EIR Process

- Project currently in the beginning steps: Distribute Notice of Preparation and Prepare Draft EIR
- Draft EIR will prepared in next coming months
- Opportunity for public comment similar to this during 60-day public review period
- Final EIR will include final mitigation measures
- EIR certification is separate from project approval Project not automatically approved at EIR certification.
- Issues to be Analyzed
  - Mineral and Agricultural Resources will not be analyzed because those resources don't exist on the site
  - Cumulative impacts include impacts of projects separate from this project proposal
  - Elaborated more on specific impacts that have been identified and will be analyzed in detail for this project
  - Shading impacts will be addressed although it is outside of the California Environmental Quality Act (CEQA) impacts, to incorporate specific concerns of community into analysis
  - Examples of medical waste: rubber gloves, face masks, syringes, etc.
  - The site is not a listed hazardous site; however, there may be listed sites in the area that impact the project site
  - Vehicle miles traveled (VMT) refers to how many miles vehicle travels regardless of vehicle type or passengers. This tool used because it links directly to impacts of greenhouse gas emissions.
  - Ingress and egress, site distance, potential circulation issues.
  - Level of service (LOS) is delay of vehicles at an intersection; can be acceptable or unacceptable. New CEQA guidelines do not include LOS impacts, replaced by VMT. LOS will still be analyzed to help decision-makers in determining impact as it related to County policies. Informational, not part of CEQA analysis.

  - Major milestones and tentative dates currently scheduled
